- Hosting the Banquet and meetings at the Georgia Aquarium. This project has been investigated by David Weeks, Gary Theisen and Shayla King(had brought up the idea).
- David Weeks had prepared handouts for the entire LSC to view on the prospect of hosting banquet at Georgia Aquarium. The
- -Banquet would be on April 15, 2012. We have reserved the space to hold the annual All-Star Banquet at 1:30pm.
- -Meeting rooms for our general business meeting 8:30am-noon is available for \$500 per hour.
 - -The total fee for the banquet and the meeting room including the food and seating for 600 people would be \$28,119.86, which breaks down into about \$44.37 per person.
 - -If the budget is approved to provide \$10,000.00 for the banquet the fee per ticket to cover the banquet would be \$27.70 per person. The proposal would be to charge each person -\$30.00 each to attend the banquet. Tickets at the door will be \$35.00.
 - -we are seeking sponsorship to cover the meeting room fees and additional money to serve as advertising arrangements with the Georgia Aquarium, which includes but not limited to advertising logos and suits, etc. at the aquariums. (For example in the Whales shark tank and the Beluga Whale tank).
 - -Additional packages available to anyone attending the banquet.
 - -Daytime Aquarium Admission for all-star families is \$16.50 per person-Open 10am-5pm
 - -Daytime Aquarium Admission PLUS Dolphin Show is \$27.75 per person. Shows are 11am and 3pm.
 - -Proposal is to have meetings at Ga Tech if available.
 - -The meeting rooms will be looked into by the General Chair, Gary Theisen.
 - -Discounted parking fee of \$7 per vehicle attending the banquet
 - -If paying at the door parking will be regular fees.

 - -Bid a meet- MUST follow the requirements set by Sanct. Committee. The bid made by a team must be SOLID. Make sure you have the correct date, use of the facility prior to the bid process, the price for each event.
 - -Divisions: North, South West, North East, South, Metro
 - -Towel Information is due Nov. 1st. Look at list, correct mistakes, only one designation-you can only have one. Money form due to Gary by Nov. 15th.

Officials- Glenda Orth

- -Travel Reimbursement for officials that are traveling to one of the National Level Meets- as defined by the LSC Board each year is available based on budgetary constraints. Each official who has been selected to work a National Level Meet should notify the Officials' Chair of their appointment. This will allow the Officials' Chair the opportunity to confirm the official has worked the 24 Ga. Swimming sessions and confirm agreement with the official to work 24 Ga. Swimming Sessions following the reimbursement.
- -The maximum reimbursed is listed in the budget for each meet.
- -Officials will only be allowed to collect any "non-big meet" reimbursement once a year and must meet the 24 session requirement.
 - -Ga Swimming will also keep the Senior Championship as Officials Qualifying Meets so there will be 2 opportunities for advancement "locally" every year.
 - -In 2011 there were 27 clinics up to date with 87 individuals trained.
 - -The 4 hour rule for swim sessions was discussed and reviewed.
- -Reviewing possibilities for into sanction fines for going over the four hour rule. ***This does not included state or national meets.

- -Officials required to be listed on the Meet information for sanctioning. These officials shall be named in the meet information prior to sanctioning:
 - Meet Referee
 - -Starter
 - -Stroke and Turn Judge
 - -Administrative Official
 - -Safety Marshal
- -Reminder of the rule for place judges- one is required but two are preferred.

SAFETY CHAIR- Kathy Clark

-Review of the process of submitting all incident reports. Incident reports should be sent to USA Swimming Meet Ref., and to the Safety Chair, Kathy Clark.

This includes all incidents regarding family members as well as swimmers. At the bottom of the incident report it tells you were to send the copies.

-Please note that you are NOT allowed to have swimmers go off the Dive platforms or Diving Boards during your practices. Risk Management will NOT pay for any

incident that might come from doing so.

- -Reminder that CPR must include age 12 and under
- -Emergency Plan that merges with facility
- -Reminder that while teaching diving it must be done in 6ft or more water.
